BANKRUPTCY REQUIREMENTS

Credit Counseling Certificates

Everyone filing for bankruptcy protection must complete an individual "Budget Briefing Session" with an approved, Non-profit Budget and Credit Counseling Agency during the 180 day period before the Bankruptcy petition is filed.

A certificate of completion must be obtained once they have completed the "Budget Briefing Session" in order to proceed to file a bankruptcy petition.

Financial Education Certificates

All filers must also complete an approved personal financial management instructional course by an approved educational provider before they can be eligible to receive a bankruptcy discharge.
