

Monica Meyer Respect Life Grant Application 2020-2021

Grant Guidelines:

- 1) This grant exists in the Catholic Foundation to assist parishes of the Diocese of Green Bay in planning and executing parish based pro-life/anti-abortion activities and events.
- 2) Funding under this grant is available up to, and including, \$1,000.00 per parish per project. Priority will be given to those projects that incorporate principles of missionary discipleship and accompaniment, and/or raise the conscience of the community. Projects will also be given priority if they will have a long term impact element, as opposed to a single event.
- 3) No project will be funded for more than three times consecutively.
- 4) A follow-up report will be expected from the project organizers to the Office of Pro-Life of the Diocese of Green Bay. Project personnel are strongly urged to submit not only written reports, but also photos, samples of flyers and any news coverage. A form will be sent out during the project year and all grant recipients will be required to submit the grant review, regardless of whether they plan to re-apply the following year.
- 5) The grant approval process involves review and recommendations by the Respect Life Selection Committee as to which applicants will receive funds.
- 6) This grant shall be awarded in a lump sum in August. **Applications will be accepted from March 25th through May 31th.** Applications received after the deadline will not be considered.
