DECREE

The teaching of religion is ever to be fostered as part of the mission of the Church to proclaim the Gospel and provide formation in the Catholic Faith. To better form disciples of the Lord in service of this mission, our policies for Religion Certification have been revised.

Thus, I hereby establish and promulgate the following policies for the certification of all catechetical personnel in Catholic Schools, Religious Education, and Youth Ministry as particular law for the Diocese of Green Bay, effective May 25, 2012. These policies replace all previous policies for the certification of catechetical personnel.

I. Introduction:

- A. The purpose of catechetical certification is to "help the whole community of faith to come to at least a basic standard of knowledge of Christ and of the teachings of the Church" and to "prepare the next generations to answer generously the call to holiness." (from Bishop David L. Ricken's Pastoral Letter A New Moment for Catechesis in the Diocese of Green Bay, November 2009). Further, Bishop Ricken announced that the new adult catechism, The United States Catechism for Adults (USCCA) is to be the foundational text for all adult faith formation and catechesis in the Diocese of Green Bay. Our certification process is to engage the whole community in the ongoing formation of their Catholic faith and to provide the best possible training for all people involved in catechesis.
- B. Catechetical certification is a requirement for all religious education administrators, youth ministers, catechists, Catholic school teachers and school administrators.
- C. The 2008 Standards for Educators in Catholic Parishes and Schools from the Wisconsin Catholic Conference set the minimum standards for the dioceses in the State of Wisconsin, and the Diocese of Green Bay has created their own standards based on these minimums.

II. Definitions:

For the purpose of these policies the following terms are defined:

III. Requirements:

- A. All catechetical leaders, catechists and teachers will achieve Foundational Catechetical Certification within six years of their hiring by successfully completing the series of six components, consisting of ten classroom hours each:
 - Creed
 - Liturgy and Sacraments
 - Morality
 - Prayer & Spirituality
 - Bible
 - Methods (either Catechist Track or Teacher Track, as appropriate)
- B. These components may be accomplished in any order, but must be successfully completed and documented in order to be valid for the purpose of certification. Courses must be conducted in accordance with the standardized lesson plans as developed and published by the Department of Education, meet for the required duration (minimum of ten classroom hours), and be taught by a trained facilitator.
- C. Once Foundational Catechetical Certification is achieved, a renewal of that status ("On-going Formation") is required annually through additional coursework by taking an approved Adult Faith

Formation or other Department of Education course; a Catholic college course (on an appropriate topic); a Foundational Catechetical Certification Course the individual is lacking; or an appropriate online course from an accredited source. Courses must meet a minimum duration requirement of ten "classroom" hours and be approved in advance by the Department of Education.

IV. Fulfilling the Requirements:

A. Prior/Existing Certification.

 From the Diocese of Green Bay: Holders of current certification will be granted equivalency for the appropriate components according to what USCCA certification courses they have completed and will be required to pursue remaining components as described in paragraph III.C above.

- 2. From other Dioceses: A review of previously earned certification (including the certification requirements of the Diocese in question and a copy of the individual's certificate from that Diocese) will take place by the Department of Education, and equivalency for the appropriate components will be granted as warranted.
- 3. From prior, formal education (including Commissioned Ministry): Individuals will submit a copy of their college/commissioned ministry transcripts documenting appropriate coursework (in one or more of the six component subject matter) to the Department of Education. If equivalency to any of the six components is granted, a certificate/letter will be issued by the Department of Education for that/those component(s) and mailed to the individual's parish/school.
- 4. From a lapsed certification: Individuals with lapsed certification, must pursue Foundational Catechetical Certification by completing all six of the components as outlined in III.A above. Certification that has been lapsed is subject to review and evaluation by the Department of Education.
- B. Foundational Catechetical Certification.
 - 1. Upon completion of any one of the components, the certification candidate should complete a verification form and submit it to the Department of Education. From this verification form, a certificate/letter acknowledging the completed component will be issued by the Department of Education and mailed to the individual's parish/school.
 - Upon completion of all six components, a certificate of Foundational Catechetical Certification
 will be issued by the Department of Education and mailed to the individual's current
 parish/school. To maintain one's certification, the individual will purse On-going Formation as
 described in paragraph III.C above.
