### Discipline with Purpose Basic Training Workshop - August 22, Hosted at Roncalli

We continue to hear from employers that people do not have the "soft skills" necessary for the workplace and beyond. DWP is a program that focuses on skills necessary for life.

Discipline with Purpose is a nationally recognized program designed to teach students in Kindergarten through 8<sup>th</sup> grade the most important skills they can learn – skills of self-discipline. In this workshop participants learn to distinguish actions that require disciplinary consequences from those that indicate self-discipline skills are missing. They learn about the 4 skills of discipline and how they fit into the wider framework of 15 self-discipline skills. They review field tested lesson plans and discover four ways to teach the 15 skills. They build action plans that are realistic and practical and can be used immediately. ## New Law Gives Sales Tax Holiday for School Supplies & Sales Tax Rebate for School Kids *Pass along to parents*



Gov. Walker signed into law on April 17 a bill that with his veto power creates a five-day holiday from sales taxes for back-to-school shoppers. The tax holiday will be August 1 to 5. It will waive taxes for school supplies and pieces of clothing that cost

less than \$75, on computers costing no more than \$750 and on computer supplies that cost no more than \$250. Consumers will save between 5% and 5.5% in sales tax, depending on the county in which they live. Retailers will not charge sales tax on qualified items.

The bill also provided families with a sales tax rebate of \$100 per school-age child for sales taxes paid in 2017. The rebate will be available to all guardians of children who are under the age of 18 throughout 2017, and not just biological parents. Families will be able to apply for the rebate beginning on May 15 through an online application with the Department of Revenue. The application deadline is June 30.

## School Safety Grant App Now Open



The Department of Justice Office of School Safety has launched its application process for the \$100 million in school safety grants approved by the Governor last month. As you begin the application process, there are some things to consider to ensure your school's participation:

- The deadline for the application is June 8, 2018.
  - Read the 21-page [document](#) that describes the application process.
  - The grant application must be done online through the E-Grant portal. A link to the DOJ E-Grant site can be found [here](#).
  - To be considered for the funding, applicants must provide their staff with a minimum of 3 hours combined training in Adverse Childhood Experiences and Trauma-Informed Care/Trauma Sensitive Schools before the end of the 2018-2019 school year or provide the DOJ evidence that the staff has already completed the required training. You can use the grant to fund the training or contact the DPI for information about free training.
  - The grant has to be submitted by the governing body of the school.
- WCRIS staff is actively involved with the Department of Justice about the grant process and will keep you updated via Current Events and the [WCRIS website](#).

## Cognitive Abilities Test (CogAt)



Prior to using MAP as the Diocesan standardized assessment we used the IOWA Test of Basic Skills and Cognitive Abilities Test (CogAt). Since moving to MAP we have been having conversation with

Houghton Mifflin regarding the availability of CogAt for any school that would like to use it in the future. It is a different assessment than both IOWA and MAP in that it assesses a student's strengths and weaknesses in Verbal, Quantitative and Non-Verbal areas. This assessment can provide valuable data in critical thinking skills. It is not a replacement for MAP but a supplemental assessment. 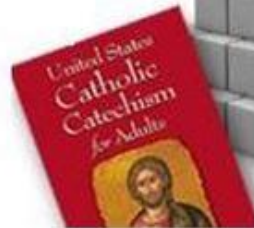
